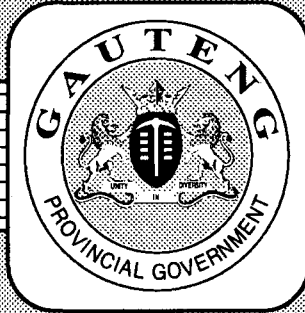

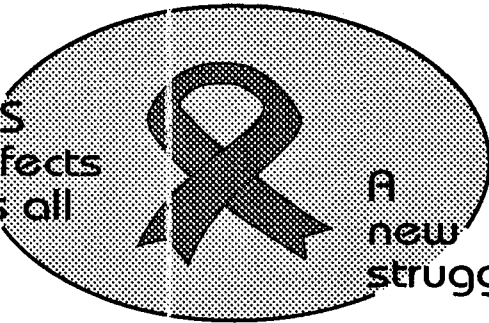

### LOCAL AUTHORITY NOTICE 129

#### CITY OF JOHANNESBURG

#### REMOVAL OF RESTRICTIONS ACT 1996 (ACT NO 3 OF 1996)

It is hereby notified in terms of section 6(8) of the Removal of Restrictions Act, 1996, that the City of Johannesburg has approved that;

- 1) Conditions B,C(b), C(c), C(d), C(e), C(f), C(g), C(i), C(j), C(k), C(l) and C(m) from Deed of Transfer T34135/1986, to be removed; and
- 2) Johannesburg Town Planning Scheme, 1979, be amended by the rezoning of Remainder of Erf 114 Fairmount Extension 2 (Proposed Portion 2 of Erf 114 Fairmount Extension 2), from "Residential 1" to "Residential 3" with a density of 20 units per hectare, subject to certain conditions, which amendment scheme will be known as Johannesburg Amendment Scheme 13-0211 as indicated on the approved application which are open for inspection at the office of the Department of Development Planning, Transportation and Environment.
- 3) Johannesburg Amendment Scheme 13-0211 will come into operation 28 days from date of publication hereof.

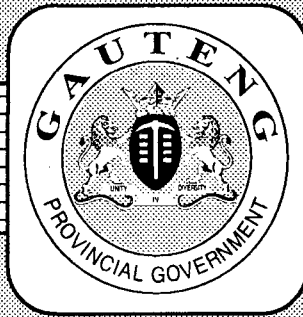

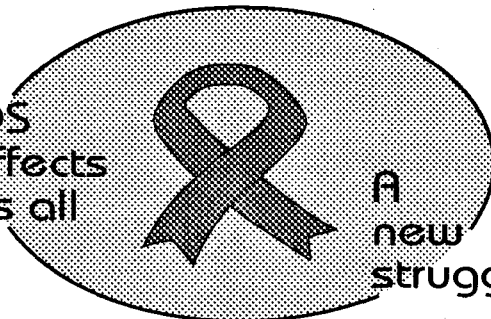
