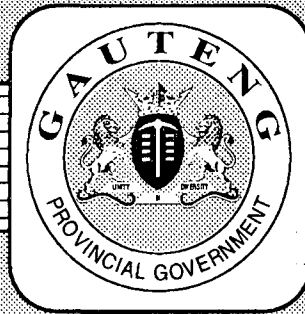

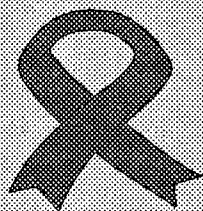

NOTICE 1982 OF 2003

GAUTENG REMOVAL OF RESTRICTIONS ACT, 1996

KEMPTON PARK AMENDMENT SCHEME 1187

It is hereby notified in terms of the provisions of the Gauteng Removal of Restrictions Act, Act 3 of 1996, that the Ekurhuleni Metropolitan Municipality (Kempton Park Service Delivery Centre) has approved that certain conditions contained in the title deeds of Portions 87, 88, 89, 90, 96, 97, 98 and 99 of the farm Zuurfontein, Registration Division 33-IR, Kempton Park be removed as well as the amendment of the Kempton Park Town Planning Scheme, 1987 by the rezoning of Portions 87, 88, 89, 90, 96, 97 and 99 from "Municipal" to "Special" for purposes related and subsidiary to a power station, and the rezoning of Portion 98 from "Municipal" to "Special" for brick-making purposes.

Map No. 3 and the scheme clauses of the amendment scheme will be open for inspection during normal office hours at the office of the City Manager, Kempton Park Service Delivery Centre, Room B301, Civic Centre, corner of C R Swart Drive and Pretoria road, Kempton Park and the office of the Head of Department, Gauteng Provincial Government : Development Planning and Local Government, Private Bag X86, Marshalltown, 2107.

The amendment scheme is known as Kempton Park Amendment Scheme 1187 and shall come into operation on the date of publication of this notice.
