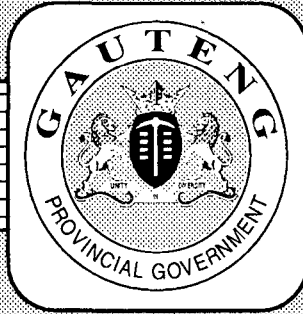

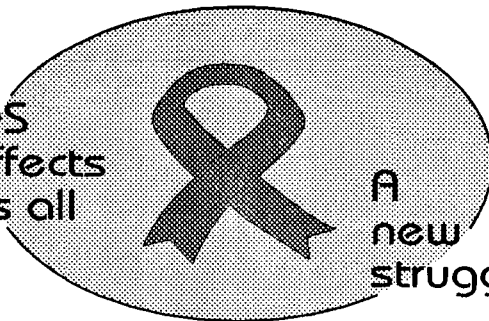

It is hereby notified in terms of section 57 (1) of the Town Planning and Townships Ordinance, 1986, that the City of Johannesburg approved the amendment of the Sandton Town-planning Scheme, 1980, by the rezoning of Erf 392, Magaliessig Extension 32, from "Residential 2, 15 dwelling units per hectare" to "Residential 2, 30 dwelling units per hectare".
