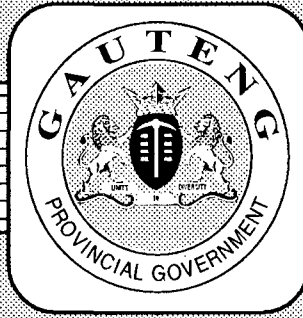

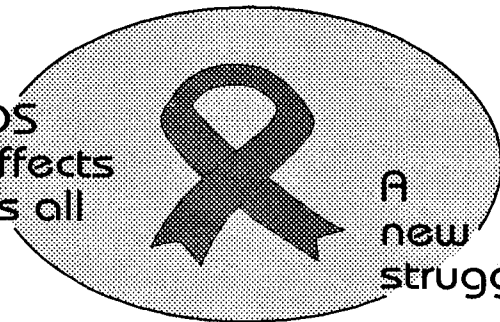

### NOTICE 1644 OF 2003

#### CITY OF JOHANNESBURG

#### AMENDMENT SCHEME 1665E

It is hereby notified in terms of section 57(1) of the Town Planning and Townships Ordinance, 1986, that the City of Johannesburg approved the amendment of the Johannesburg Town-Planning, 1979, by rezoning of Portion 1 of Erf 207 Linksfield Extension 5, from "Residential 2" to "Special for medical facilities, professional suites, dwelling-units and parking".
