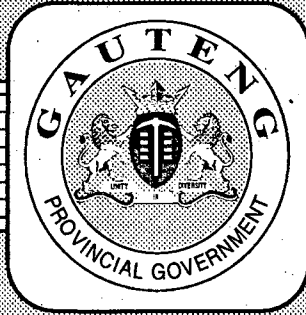

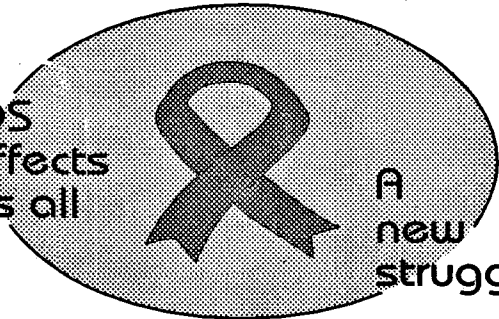

 REMOVAL OF RESTRICTION ACT, 1996

It is hereby notified in terms of section 6(8) of the Removal of Restriction Act, 1996, that the City of Johannesburg has approved that:

- 1) Conditions B.(a) to B.(m) and C.(a) to C.(d) in Deeds of Transfer T28338/1993 and T36660/1985 in respect of Erven 3081 and 3082 Bryanston Extension 7, be removed; and
- 2) Sandton Town-Planning Scheme, 1980, be amended by the rezoning of Erven 3081 and 3082 Bryanston Extension 7 from "Residential 1" to "Special" for offices, a showroom, a filling station and related convenience store, automatic teller machine, car wash facility, places of refreshment and ancillary and related uses, subject to certain conditions, which amendment scheme will be known as Sandton Amendment Scheme 1326E as indicated on the approved application which are open for inspection at the office of the Executive Director: Development Planning, Transportation and Environment, 158 Loveday street, Braamfontein, 8th floor, A Block, Civic Centre
