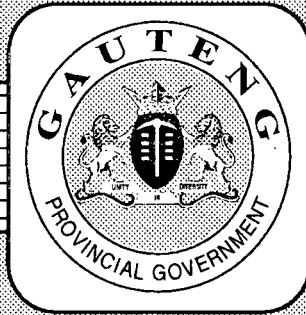

The Ekurhuleni Metropolitan Municipality (Kempton Park Service Delivery Centre) hereby gives notice in terms of Section 57(1)(a) of the Townplanning and Townships Ordinance, 1986 (Ordinance 15 of 1986), that the application for the rezoning of Erf 1566 Esther Park Extension 9, Kempton Park from "Special" for certain uses as mentioned in the relevant annexure to "Special" for shops, offices, places of refreshment, places of amusement, places of instruction, social halls, fish mongers, financial institutions, dry cleaners, motor traders, motor workshops subservient and related to the motor traders, parking garage, drive-in restaurants and butchery, subject to certain conditions, has been approved.

Map-3 documents and Scheme Clauses of the amendment scheme will be open for inspection during normal office hours at the office of the Acting Head : Kempton Park Service Delivery Centre, Room B301, Civic Centre, corner of C R Swart Drive and Pretoria Road, Kempton Park and the office of the Head of Department, Gauteng Provincial Government : Development Planning and Local Government, Private Bag X86, Marshalltown, 2107.
