



# GAUTENG PROVINCIAL GOVERNMENT DEPARTMENT OF FINANCE AND ECONOMIC AFFAIRS

REGULATIONS IN TERMS OF SECTION 84 OF THE GAUTENG GAMBLING ACT, 1995 (ACT NO. 4 OF 1995)
