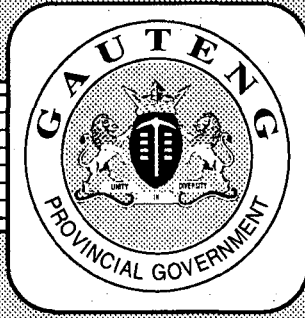

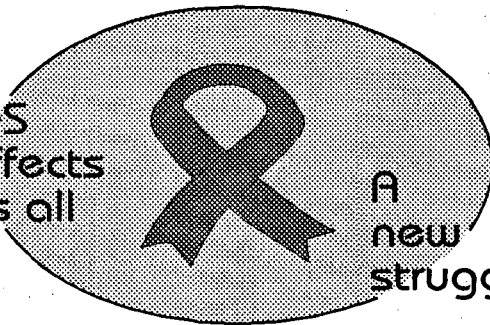

### LOCAL AUTHORITY NOTICE 2204 OF 2003

#### EKURHULENI METROPOLITAN MUNICIPALITY BOKSBURG EAST EXTENSION 12 TOWNSHIP

#### RECTIFICATION TO LOCAL AUTHORITY NOTICE 1957 (AFRIKAANS AND ENGLISH TEXTS) AND WITHDRAWAL OF BOTH LOCAL AUTHORITY NOTICE 1971 (AFRIKAANS AND ENGLISH TEXTS) AND LOCAL AUTHORITY NOTICE 1972 (ENGLISH AND AFRIKAANS TEXTS)

#### I. RECTIFICATION

The Ekurhuleni Metropolitan Municipality hereby publishes the following rectification to Local Authority Notice 1957 published in Provincial Gazette Extraordinary No 422 of 6 December 2002.

In the "Schedule" setting out the conditions under which the application for the establishment of Boksburg East Extension 12 township has been approved:-

- (a) insert "and a road" after "733" where the latter appears in condition of establishment 1.3(b) as contained in the English text of Local Authority Notice 1957; and
- (b) insert "en 'n straat" after "733" where the latter appears in condition 1.3(b) as contained in the Afrikaans text of Local Authority Notice 1957.

#### II. WITHDRAWAL

Local Authority Notice 1971 and Local Authority Notice 1972, both published in English and Afrikaans in the Provincial Gazette Extraordinary No. 428 of 9 December 2002 are hereby withdrawn.
