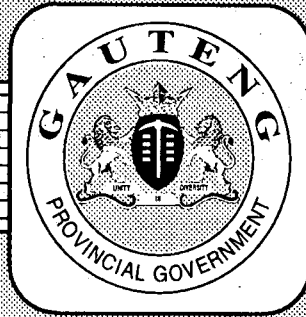

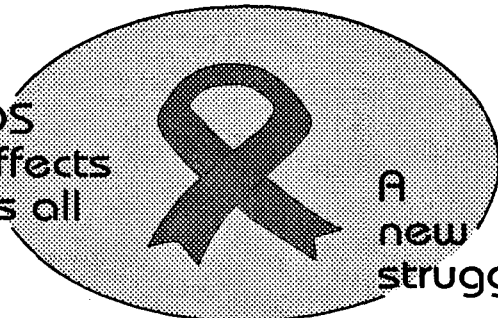

AMENDMENT SCHEME 02-0231
