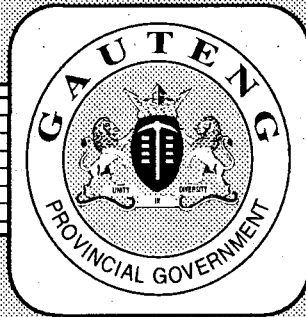

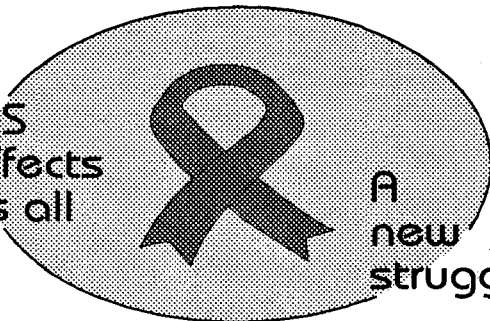

AMENDMENT SCHEME 01-1176

It is hereby notified in terms of section 57 (1) of the town Planning and Townships Ordinance, 1986, that the City of Johannesburg approved the amendment of the Johannesburg Town Planning Scheme, 1979, by the rezoning of erf 24 Eikenhof Extension 3 from "Residential 3" to "Residential 1" permitting a density of one dwelling unit per erf, "Public Open Space" and "New Roads and Widenings".
