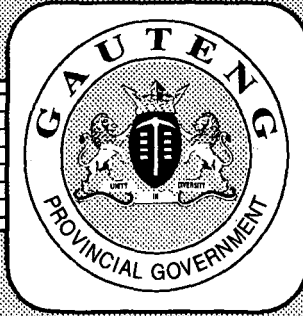

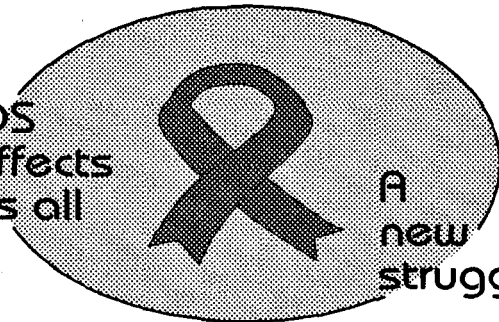

#### CITY OF JOHANNESBURG

GAUTENG REMOVAL OF RESTRICTIONS ACT, 1996 (ACT No. 3 OF 1996)

NOTICE No. 918 OF 2003

It is hereby notified in terms of section 6 (8) of the Gauteng Removal of Restrictions Act, 1996, that the City of Johannesburg has approved that:

(1) Conditions (c) to (t) from Deed of Transfer T13624/1991, in respect of the Remaining Extent of Erf 542 Bryanston be removed, and

(2) Sandton Town-Planning Scheme, 1980, be amended by the rezoning of Erf 542, Bryanston from "Residential 1" to "Residential 1" subject to certain conditions which amendment scheme will be known as Sandton Amendment Scheme 02-0517 as indicated on the approved application which are open for inspection at the office of the Executive Director: Development Planning, Transportation and Environment, 158 Loveday Street, Braamfontein, 8th Floor, A Block, Civic Centre, and are open for inspection at all reasonable times.

(3) Sandton Amendment Scheme 02-0517 will come into operation on the date of publication hereof.
