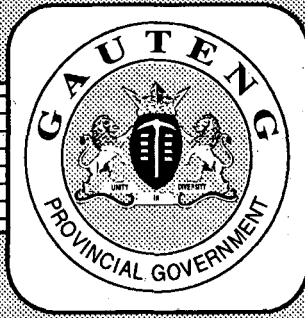

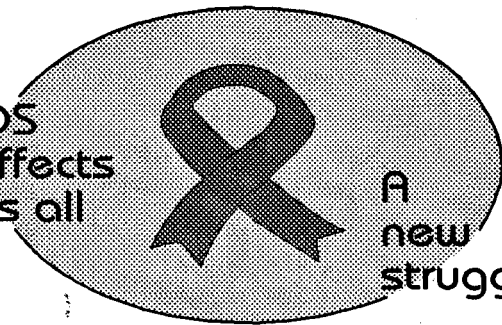

It is hereby notified in terms of section 6(8) of the Removal of Restriction Act, 1996, that the City of Johannesburg has approved that:

- 1) Conditions B.(a) to B.(m) and C.(a) to C.(d) in Deeds of Transfer T34446/1964 and T37014/1988 in respect of Erven 3117 and 3118 Bryanston Extension 7, be removed; and
