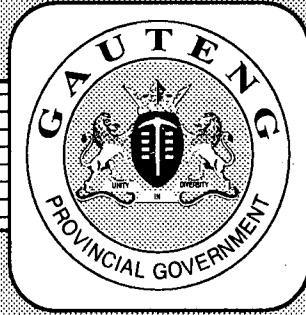

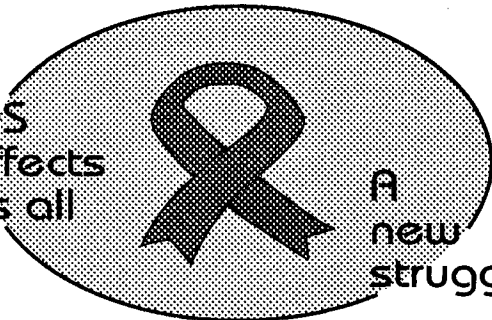

LOCAL AUTHORITY NOTICE 476

CORRECTION NOTICE

The City of Johannesburg herewith gives notice that Local Authority Notice 2149 dated 9 September 1998, in respect of Sharonlea Extension 20, is herewith amended as follows:

1. By the insertion after clause 1(10) in the English notice, of the following:

“(11) Restriction on the transfer of erven

Erven 744 and 745 shall be transferred only to the Residents Association established in respect of the township, which Association shall have full responsibility for the functioning and proper maintenance of the erven and the essential services within the said erven.”

2. By the substitution of clause 2(4) in the English notice, for the following:

“(4) Erven 744 and 745

- (a) The entire erven are each subject to a servitude for municipal purposes as indicated on the General Plan.
- (b) The erven shall not be alienated or transferred into the name of any purchaser other than the Residents Association established in respect of the township, unless the written consent of the local authority first having been obtained.”

3. By the insertion after clause 1(10) in the Afrikaans notice, of the following:

“(11) Beperking op die oordrag van erwe

Erwe 744 en 745 mag slegs aan die Inwonersvereniging wat ten opsigte van die dorp gestig is, oorgedra word, welke Vereniging volle verantwoordelikheid sal dra vir die funksionering en behoorlike instandhouding van die erwe en die noodsaaklike dienste binne die gemelde erwe.”

4. By the substitution of clause 2(4) in the Afrikaans notice, for the following:

“(4) Erwe 744 en 745

- (a) Die totale erwe is elk onderworpe aan 'n serwitut vir munisipale doeleindes soos aangedui op die Algemene Plan.
- (b) Die erwe mag nie vervreem of oorgedra word in die naam van enige koper behalwe diè van die Inwonersvereniging wat vir die dorp gestig is, tensy die skriftelike toestemming van die plaaslike bestuur eers verkry is.”

Die Stad van Johannesburg gee hiermee kennis dat dat Plaaslike Bestuurskennisgewing 2149 gedateer 9 September 1998, ten opsigte van Sharonlea Uitbreiding 20, hiermee soos volg gewysig is:

1. Deur die invoeging na klousule 1(10) in die Afrikaanse kennisgewing, van die volgende:

“(11) Bepanking op die oordrag van erwe

“(4) Erven 744 and 745

(c) The entire erven are each subject to a servitude for municipal purposes as indicated on the General Plan.

(b) The erven shall not be alienated or transferred into the name of any purchaser other than the Residents Association established in respect of the township, unless the written consent of the local authority first having been obtained.”
