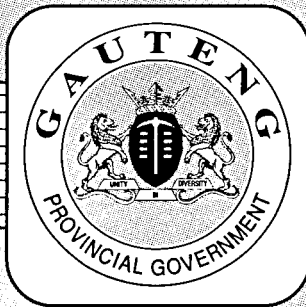

### NOTICE 973 OF 2004

### INCORPORATION OF BEKKERSDAL INTO THE WESTONARIA TOWN PLANNING SCHEME, 1981

#### WESTONARIA AMENDMENT SCHEME 91

The Westonaria Local Municipality hereby, in terms of Section 125 of the Town Planning and Township Ordinance, 15 of 1986, declares that it has received an Amendment Scheme, being an amendment to the Westonaria Town Planning Scheme, 1981, comprising the same land as Bekkersdal Proper, for approval.

The Map 3 and the scheme clauses for the amendment scheme will lie for inspection for a period of 28 days, from 31 March 2004, at the office of the Town Planner, in Room 109 of the Municipal Building on the corner of Neptunus and Saturnus Streets, Westonaria.

Comments on the draft maps and annexures should be submitted in writing to the above office or posted to PO Box 19, Westonaria, 1780 before or on 28 April 2004.

This amendment scheme is known as Westonaria Amendment Scheme 91.
