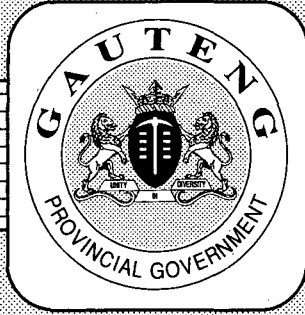

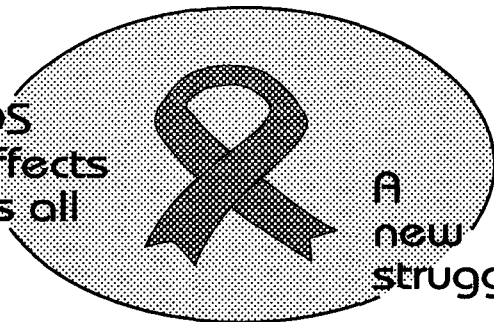

AMENDMENT SCHEME 07-1730
