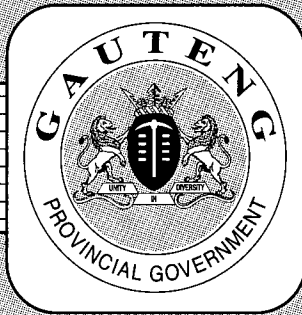

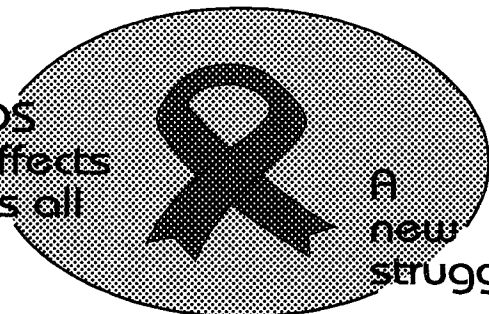

### NOTICE 3464 OF 2004

#### CITY OF JOHANNESBURG

#### REMOVAL OF RESTRICTIVE ACT, 1996 (ACT No. 3 OF 1996)

It is hereby notified in terms of section 6 (8) of the Removal of Restrictions Act, 1996, that the City of Johannesburg, has approved that:

(1) conditions (d), (e), (f), (g), (h), (j), (k), (l), (n), (o), (p), (r), (s), (t) and (u) from Deed of Transfer T3287/1991, in respect of Erf 2242 Bryanston, be removed;  
and

(2) Sandton Town-planning Scheme, 1980, be amended by the rezoning of Erf 2242 Bryanston, from "Residential 1", one dwelling unit per erf to "Residential 1", permitting a density of 10 dwelling units per hectare, subject to certain conditions, which amendment scheme will be known as Sandton Amendment Scheme 13-1771 as indicated on the approved application which are open for inspection at the office of the Executive Director: Development Planning, Transportation and Environment, 158 Loveday Street, Braamfontein, 8<sup>th</sup> Floor, A Block, Civic Centre, and are open for inspection at all reasonable times.

(3) Sandton Amendment Scheme 13-1771 will come into operation on the date of publication hereof.
