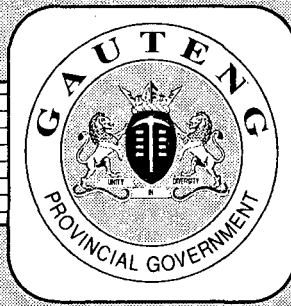

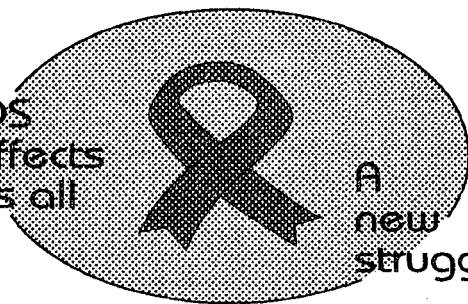

1.6 DEMOLITION OF BUILDINGS AND STRUCTURES

When required by the City of Tshwane Metropolitan Municipality to do so, the township owner shall at his own expense cause to be demolished to the satisfaction of the City of Tshwane Metropolitan Municipality all existing buildings and structures situated within building line reserves and side spaces or over common boundaries, or dilapidated structures.

1.7 REMOVAL OF LITTER

The township owner shall at his own expense have all litter within the township area removed to the satisfaction of the City of Tshwane Metropolitan Municipality, when required to do so by the City of Tshwane Metropolitan Municipality.

"(r) Specially subject to a servitude of right of way along the road shown on Diagram No A715/1924, annexed to Deed of Transfer No 10127/1925, in favour of the owners of the following portions of Portion G of the farm "THE WILLOWS" No 23, district Pretoria: -

(1) Portion 3, transferred by Deed of Transfer No 3094/1928, dated 26th March, 1928;

(2) Portion 4, transferred by Deed of Transfer No 452/1928, dated 20th January 1928;

(3) Portion 5, transferred by Deed of Transfer No 4671/1928, dated 4th May 1928; and

(4) Portion 12, transferred by Deed of Transfer No 6925/1937, dated 14th April 1937;
