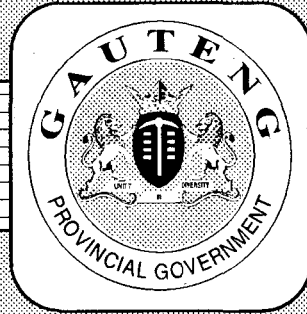

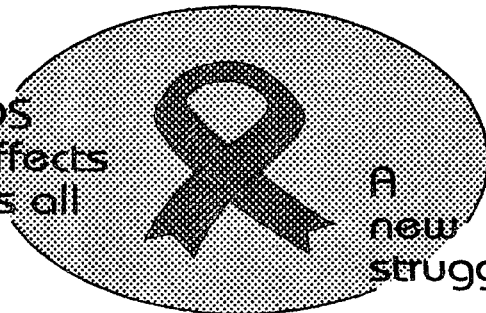

PROCLAMATION OF A ROAD

We, Qedani Dorothy Mahlangu and Jabulani Lukas Mahlangu, Members of the Executive Councils responsible for Local Government in the Provinces of Gauteng and Mpumalanga respectively, by the power vested in us by section 4 of the Local Authorities Roads Ordinance, 1904, hereby proclaim the road as prescribed in the Schedule hereto as a public road, under the jurisdiction of the Ekurhuleni Metropolitan Municipality.
