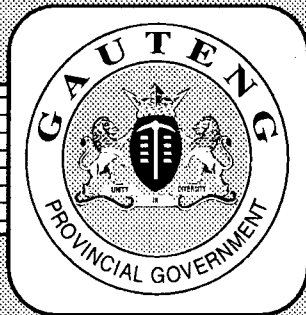

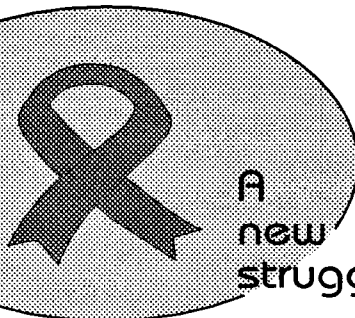

**LOCAL AUTHORITY NOTICE 45****NOTICE OF CORRECTION****Midstream Estate Extension 2 (District Ekurhuleni Metropolitan Municipality)**

Clause 1 (6) of the Conditions of Establishment of Midstream Estate Extension 2 Township published in the Gauteng Provincial Gazette No 517 dated 25 November 2003 (hereinafter referred to as the conditions) is hereby amended by the deletion of the number "366" from the clause.

Clause 1 (6) should read as follows: "Erven 260, 273, 286, 301, 365, 367, 387, 401 and 402 shall be transferred at the expense of the township owner to the home owners' association, being a company established in terms of Section 21 of the Companies Act."
