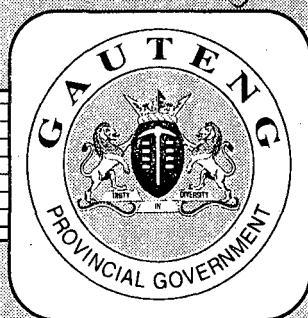

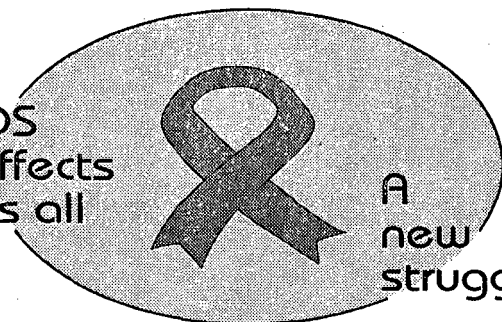

NOTICE 580 OF 2004

GAUTENG PROVINCIAL GOVERNMENT

DEPARTMENT OF FINANCE AND ECONOMIC AFFAIRS REGULATIONS IN TERMS OF SECTION 84 OF THE GAUTENG GAMBLING ACT, 1995 (ACT NO. 4 OF 1995)

I, Phillip Jabulani Moleketi, Member of the Executive Council responsible for Finance and Economic Affairs have, under Section 84 of the Gauteng Gambling Act, 1995 (Act No 4 of 1995), made the amendment Regulations set out in the Schedule.

The Regulations take effect from 1 April 2004.

AMENDMENT OF REGULATION 82 OF THE REGULATIONS

1. The following regulation is substituted for regulation 82:

AMENDMENT OF REGULATION 242 OF THE REGULATIONS

12. Regulation 242 is amended by the substitution for sub-regulation (1) of the following sub-regulation:

✓ (1) Every holder of a totalizator licence which is not a special totalizator licence contemplated in section 97 of the Act, shall pay a licence fee of ~~R70 537,50~~ ~~R76 180,50~~ plus ~~R706,80~~ ~~R763,80~~ per site outlet for every year or part of a year ending on 31 August."

AMENDMENT OF REGULATION 250 OF THE REGULATIONS

250 In addition to any tax, fee or levy payable in terms of the provisions of the Act, there shall be paid to the board, in terms of section 61 of the Act, by [the] holder of a totalizator licence contemplated in section 53 of the Act, on the gross takings of a totalizator conducted by it, a levy calculated at such percentage as prescribed in regulation 254.

AMENDMENT OF REGULATION 251 OF THE REGULATIONS

251 With [sic] twenty-one days from the date on which the event took place the holder of a totalizator licence contemplated in section 53 of the Act shall -

- ✓ (a) in the form and in the manner required by the board, submit a return to the board showing the gross taking of the totalizator which the holder of a totalizator licence contemplated in section 53 of the Act conducted; and
- (b) simultaneously pay the amount of the levy of those takings as contemplated in regulation 247 to the board.

AMENDMENT OF REGULATION 252 OF THE REGULATIONS

✓ 252 The provisions of regulation 245 shall *mutatis mutandis* apply in respect of the levy contemplated in regulation 250.

AMENDMENT OF REGULATION 255 OF THE REGULATIONS

✓ 255 The levy payable in terms of regulation 251 shall be calculated in respect of as totalizator conducted by the holder of a totalizator licence contemplated in section 53 in respect of events or contingencies other than horse-racing at a rate of two percent of the gross takings of such totalizator.
