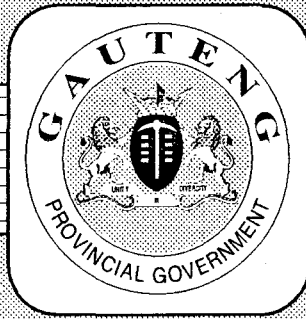

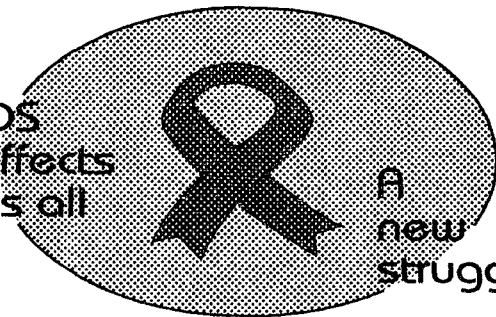

### NOTICE 2009 OF 2005

#### NOTICE FOR THE PROPOSED MERGER OF ORLANDO HIGH SCHOOL AND ALTEM SECONDARY SCHOOL

1. By virtue of the power vested in me in terms of section 12A of the South African Schools Act (Act 84 of 1996) I, Angelina Matsie Motshekga, being a Member of the Executive Council responsible for Education, hereby intends to merge Orlando High School with Altem Secondary School. Such combined school shall be housed at Altem Secondary School. (Kindly take note that the aforementioned schools have been provisionally merged by agreement between the parties).
  
2. The reasons for the proposed merger are the following:
  - To ensure compliance by the department with the provisions of the Public Finance Management Act and Section 195 of the Constitution to use the resources of the state cost-effectively and efficiently. There is serious under-utilization of space at Both Altem Secondary School and Orlando High School while there is overcrowding at Job Rathebe Primary School ;
  
  - To ensure that there is effective teaching and learning at Job Rathebe Primary School, Altem Secondary School and Orlando High School; -

- To provide the learners of Job Rathebe Primary School with learning space at Orlando High School as the former school is overcrowded.
  - The other reason to merge Orlando High School with Altem Secondary School and house them at Altem Secondary School is the fact that where Altem Secondary School is located, there are no High Schools as compared to where Orlando High School is located.
3. The governing bodies of Orlando High School, Altem Secondary School, Job Rathebe Secondary School and other interested persons are invited to make representations within 90 days of this notice. You can forward your representation to the following:
