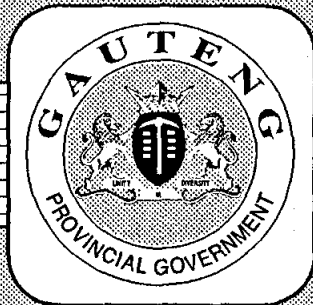

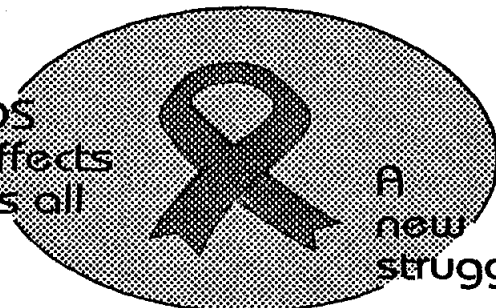

NOTICE 3361 OF 2005

ROAD TRAFFIC ACT 1996 (ACT NO. 93 OF 1996)

NOTICE OF REGISTRATION OF TESTING STATION (SECTION 39) AND AUTHORITY TO APPOINT EXAMINERS OF VEHICLES (SECTION 3A(1)(f))

I, Klaus Gerhard Schmid, (Acting) Director (Transportation Engineering) authorized under section 91 of the Road Traffic Act, 1996, (Act No. 93 of 1996)-

- (1) hereby give notice in terms of section 39 of the Road Traffic Act, 1996, of the registration of Constantia Test Station T/A Clearwater Testing Station with infrastructure number 49512D2C as an A-Grade testing station; and
- (2) hereby determine under section 3A(1)(f) of the Road Traffic Act, 1996, Constantia Test Station T/A Clearwater Testing Station with infrastructure number 49512D2C to be an authority which may appoint a person as an examiner of vehicles, on condition that -
 - (a) such a person has obtained a diploma in the examination for examiners of vehicles at a centre approved by the Minister of Transport; and
 - (b) appointment takes place subject to the condition that vehicles may only be examined at Constantia Test Station T/A Clearwater Testing Station.

Ek, Klaus Gerhard Schmid, (Waarnemende) Direkteur (Verkeers Ingenieurswese), ingevolge artikel 91 van die Padverkeerswet, 1996 (Wet No. 93 van 1996), gemagtig, -

- (1) gee hiermee, ingevolge artikel 39 van die Padverkeerswet, 1996, kennis van die registrasie van Constantia Test Station T/A Clearwater Toetsstasie, met infrastruktuurnommer 49512D2C as 'n A-Graad toetsstasie; en
 - (2) bepaal hiermee kragtens artikel 3A(1)(f) van die Padverkeerswet, 1989, dat Constantia Test Station T/A Clearwater Toetsstasie met infrastruktuurnommer 49512D2C 'n instansie is wat 'n persoon as 'n ondersoeker van voertuig kan aanstel, op voorwaarde dat -
