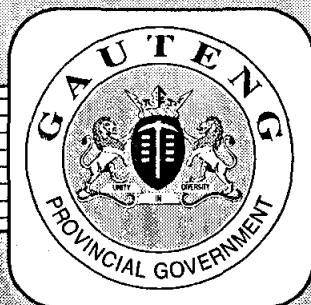

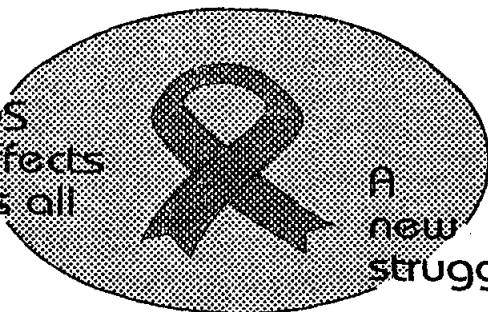

**DETERMINATION OF SALARIES AND ALLOWANCES OF MEMBERS OF THE
EXECUTIVE COUNCIL AND THE DIFFERENT MEMBERS OF THE
PROVINCIAL LEGISLATURE: GAUTENG PROVINCE**

- 1 I, MBHAZIMA SHILOWA, Premier of the Gauteng Province, under section 6(3)(a) of the Remuneration of Public Office Bearers Act, 1998 (Act 20 of 1998) ("the Remuneration Act"), read with Proclamation by the President 48 of 2005, published in *Government Gazette* 28010 on 7 September 2005 ("the Proclamation"), hereby determine that the annual salaries and allowances of Members of the Executive Council and the different Members of the Provincial Legislature specified in Column 1 of the Schedule shall be as set out in Columns 2, 3 or 4 of the Schedule with effect from 1 April 2005.
- 2 Column 4 of the Schedule applies to a re-elected Member who has occupied his or her current office, or an office of the same or higher grade according to Column 1 of the Schedule, for a period of at least 24 months in total, whether before or after 14 April 2004.
- 3 Column 3 of the Schedule applies to all re-elected Members other than those referred to in paragraph 2. When a re-elected Member to whom Column 3 applies has held his or her current office, or an office in the same or a higher grade according to Column 1, for a period of 24 months in total, Column 4 becomes applicable to that Member.
- 4 Column 2 of the Schedule applies to all Members of the Executive Council and Members of the Legislature who are not re-elected Members.
- 5 For the purposes of calculating the period of 24 months referred to in paragraphs 2 and 3, a re-elected Member who-
 - (i) was a Minister, Deputy Minister, a Member of Parliament or of a Provincial Legislature on 13 April 2004; and
 - (ii) pursuant to the elections of 14 April 2004, was designated by the Electoral Commission as a Member of the National Assembly or a Provincial Legislature, or appointed as a permanent delegate to the National Council of Provinces (NCOP) in terms of section 61(2)(b) of the Constitution,

is regarded to have continued to occupy the position occupied by him or her on 13 April 2004 until so designated or appointed.

- 6 In this Notice-

"re-elected member" means a person-

- (i) who at any time before 14 April 2004 was a member of the National Assembly or a permanent delegate to the National Council of Provinces or occupied an office mentioned in Column 1; and
- (ii) whose service in any one or more of those offices has not been interrupted at any time for a continuous period of more than 24 months."

7 Except for the salaries and allowances provided for in this Notice, the office bearers mentioned in Column 1 of the Schedule are not entitled to any other remuneration, whether directly or indirectly, in respect of the offices held by them.

8 Premier's Notice 19 of 2004, published in *Provincial Gazette* Extraordinary 513 of 17 November 2004, is hereby repealed.

**DETERMINATION OF SALARIES AND ALLOWANCES OF
MEMBERS OF THE EXECUTIVE COUNCIL AND THE DIFFERENT
MEMBERS OF THE PROVINCIAL LEGISLATURE: GAUTENG
PROVINCE**

1. I, Mbhazima Shilowa, Premier of the Gauteng Province, under section 6(3)(a) of the Remuneration of Public Office Bearers Act, 1998 (Act No. 20 of 1998) ("the Remuneration Act"), read with Proclamation by the President No. 48 of 2005, published in Government Gazette No. 28010 on 7 September 2005 ("the Proclamation"), hereby determine that the annual salaries and allowances of Members of the Executive Council and the different Members of the Provincial Legislature specified in Column 1 of the Schedule shall be as set out in Columns 2, 3 or 4 of the Schedule with effect from 01 April 2005.
2. Column 4 of the Schedule applies to a re-elected Member who has occupied his or her current office, or an office of the same or higher grade according to Column 1 of the Schedule, for a period of at least 24 months in total, whether before or after 14 April 2004.
3. Column 3 of the Schedule applies to all re-elected Members other than those referred to in paragraph 2. When a re-elected Member to whom Column 3 applies has held his or her current office, or an office in the same or a higher grade according to Column 1, for a period of 24 months in total, Column 4 becomes applicable to that Member.

4. Column 2 of the Schedule applies to all Members of the Executive Council and Members of the Legislature who are not re-elected Members.

5. For the purposes of calculating the period of 24 months referred to in paragraphs 2 and 3, a re-elected Member who –

(i) was a Minister, Deputy Minister, a Member of Parliament or of a Provincial Legislature on 13 April 2004; and

(ii) pursuant to the elections of 14 April 2004, was designated by the Electoral Commission as a Member of the National Assembly or a Provincial Legislature, or appointed as a permanent delegate to the National Council of Provinces (NCOP) in terms of section 61(2)(b) of the Constitution,

is regarded to have continued to occupy the position occupied by him or her on 13 April 2004 until so designated or appointed.

6. In this Notice –

“re-elected member” means a person –

(i) who at any time before 14 April 2004 was a member of the National Assembly or a permanent delegate to the National Council of Provinces or occupied an office mentioned in Column 1; and

- (ii) whose service in any one or more of those offices has not been interrupted at any time for a continuous period of more than 24 months."

7. Except for the salaries and allowances provided for in this Notice, the office bearers mentioned in Column 1 of the Schedule are not entitled to any other remuneration, whether directly or indirectly, in respect of the offices held by them.
8. Premier's Notice No. 19 of 2004, published in Provincial Gazette Extraordinary No. 513 of 17 November 2004, is hereby repealed.

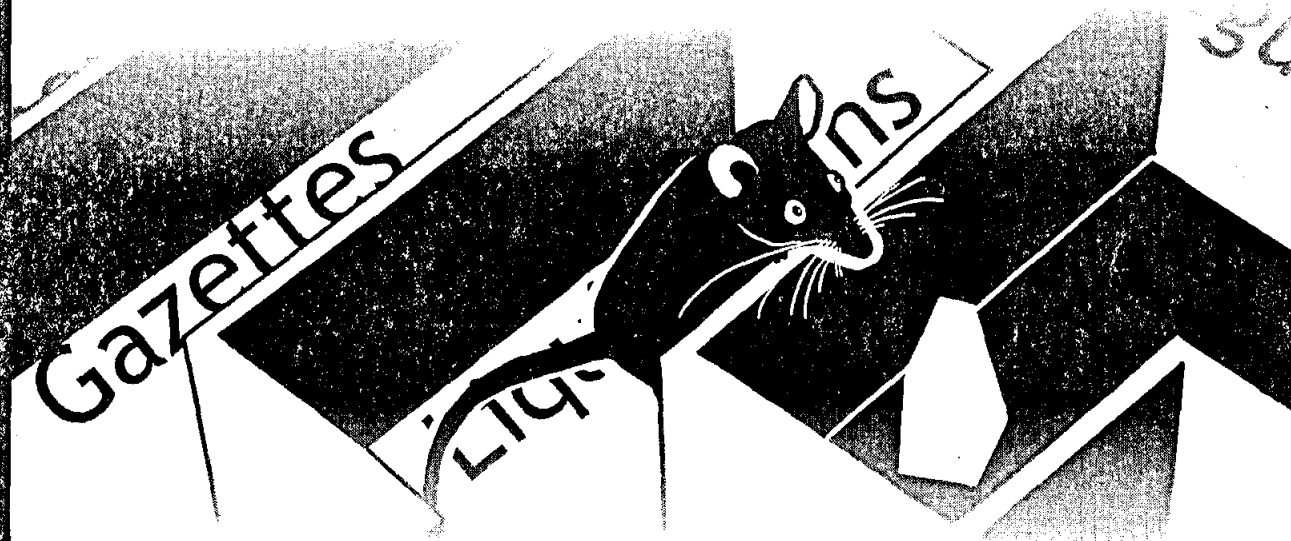
