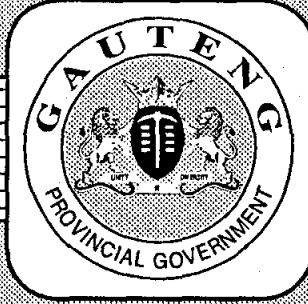

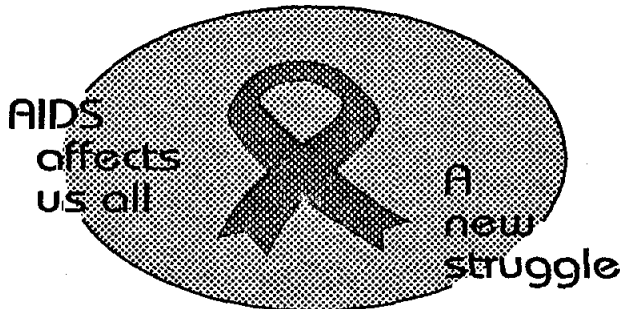

NOTICE 3961 OF 2005

MUNICIPAL DEMARCATION BOARD

REDETERMINATION OF MUNICIPAL BOUNDARIES IN TERMS OF THE LOCAL GOVERNMENT: MUNICIPAL DEMARCATION ACT, 1998, READ WITH SECTION 2 OF THE LOCAL GOVERNMENT: CROSS-BOUNDARY MUNICIPALITIES ACT, 2000, AND THE LOCAL GOVERNMENT: MUNICIPAL STRUCTURES ACT, 1998: PUBLICATION OF BOARD DECISION IN TERMS OF SECTION 21(5)(c) OF THE DEMARCATION ACT, 1998.

(North West/Gauteng)

In terms of section 22 of the Local Government: Municipal Demarcation Act, 1998, the Minister of Provincial and Local Government requested the Municipal Demarcation Board to re-determine the boundaries of certain municipalities. Details of the proposed changes were gazetted in Government Gazette No. 27937 of 19 August 2005, and the Board complied with section 26 of the Demarcation Act, 1998.

In terms of section 21(1) of Local Government: Municipal Demarcation Act, 1998, (Act No.27 of 1998) the Municipal Demarcation Board re-determined the boundaries of West Rand District Municipality (CBDC8) and Southern District Municipality (DC40). Notice No. 3359 was gazetted in the Gauteng Provincial Gazette No. 375 of 2 September 2005, and Notice No. 458 was gazetted in North West Provincial Gazette No. 6208 of 2 September 2005.

In terms of section 21 the Board has considered all objections and has decided to withdraw its re-determination.

The designations/municipal codes of the affected municipalities are published for general information.
