

PUBLIC NOTICE TO APPLY FOR VACANCY ON PUBLIC SERVICE COMMISSION

(Commissioner appointed by President upon nomination of Premier)

The Public Service Commission is established by section 196(1) of the Constitution of the Republic of South Africa, 1996 (Act No. 108 of 1996). The Public Service Commission is mandated to promote the values and principle of public administration outlined in section 195 of the Constitution and to investigate, monitor and evaluate the organizational, administrative and personnel practice within the Public Service. The Commission initiates investigations and research on its own and responds to request from national and provincial organs of state. It is an independent institution, which is accountable to the National Assembly and must report at least annually to the National Assembly and to respective Provincial Legislatures about its activities in the provinces.

The President following a nomination of the Premier of Gauteng upon approval of the Provincial Legislature of Gauteng appoints one commissioner of the Public Service Commission. A vacancy for a commissioner on the Commission resident in Gauteng will arise on 1 February 2006.

Any person who is a South African citizen, fit and proper, with knowledge of, or experience in administration, management or the provision of public service, is hereby invited to apply for the said vacancy.

Applications must contain proof of South African citizenship and complete Curriculum Vitae, including, but not limited to, information regarding the applicant's knowledge of, or experience in, administration, management or the provision of public service.
