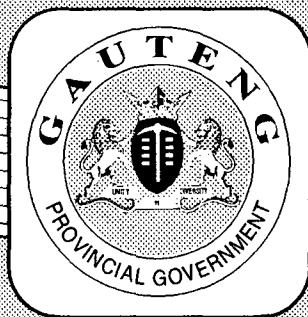

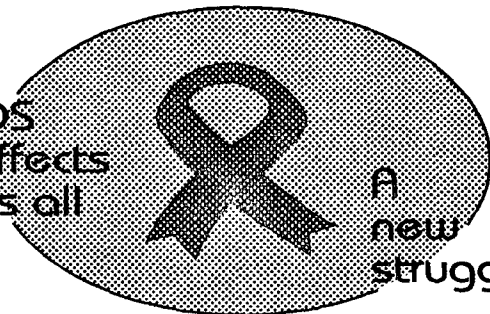

2.1.4 Erwe 1112, 1115, 1116 en 1118

Die erwe is onderworpe aan 'n 3 meter wye serwituut vir stormwater doeleindes ten gunste van die plaaslike bestuur, soos op die algemene plan aangedui.

NOTICE NUMBER 127 OF 2005

Local Authority Notice 127 of 2005 for the proposed township Sundowner Extension 41, which appeared in the Provincial Gazette of 27 January 2005, is hereby bettered by replacing condition 1.5.5 and 2.1.4 in the English Notice with the following conditions:

1.5.5 the right of way servitude registered in terms of Notarial Deed of Servitude No K483/2005 S and indicated by the figure a b D E on diagram S.G. No. A2396/1943 which affects Erven 1114 and 1115 in the township only.

2.1.4 Erven 1112, 1115, 1116 and 1118

The erven are subject to a 3 meter wide servitude for storm water purposes in favour of the local authority, as indicated on the general plan.
