**MEMORANDUM**

**PROPOSED PROCLAMATION OF A PUBLIC ROAD OVER PORTION 8 OF  
ERF 882 BAKERTON EXTENSION 4, SPRINGS**

**1. PURPOSE**

To obtain approval in terms of section 4 of the Local Authorities Roads Ordinance, 1904 (Ordinance No. 44 of 1904), for the proclamation of a road over the above-mentioned property, under the jurisdiction of Ekurhuleni Metropolitan Municipality.

**2. DELIBERATION**

- 2.1 The Ekurhuleni Metropolitan Municipality has lodged an application for the proclamation of a public road over the Remaining portion 8 of Erf 882 Bakerton Extension 4 Township.
- 2.2 The reason for the proclamation is that the Electrical and Mechanical Engineering is in favour of obtaining the relevant portion, i.e. portion 8 of erf 882, as the said portion is required for maintenance of the existing electrical services within the portion.
- 2.3 The Rand Selection Corporation Limited donated Portion 8 of Erf 882 Bakerton Extension 4, Springs to the disestablished City Council of Springs. The said portion is the road portion (previously referred to as the Remainder) of Erf 882 of Bakerton Extension 4, Springs. The Remainder of Erf 882, seems to be the road portion of the subdivision, known as Cinnamon Close, 839m<sup>2</sup> in extent.
- 2.4 A copy of the extract from the Minutes of the Executive Council meeting held on 19 September 2000, as well as a certified extract of the resolution of the dis-established City Council of Springs, is hereto attached as annexure "C".

- 2.5 The Council followed all the prescribed procedures and no objections to the proposed proclamation have been received.
- 2.6 The portion affected is shown on the locality plan and the Surveyor-General's diagrams as attached hereto as Annexure "A" and "B" respectively.
- 2.7 The Local Authorities Roads Ordinance, 1904, has been assigned to the MEC for Local Government in terms of Executive Councils' Resolution No. 145 of 17 July 1996.
