MUNICIPAL DEMARCATION BOARD NOTICE IN TERMS OF SECTION 21 OF THE LOCAL GOVERNMENT: MUNICIPAL DEMARCATION ACT, 1998 (Gauteng)

Under Section 21 of the Local Government: Municipal Demarcation Act, 1998 (Act No.27 of 1998) the Municipal Demarcation Board has re-determined the boundaries of:

- a) Ekurhuleni Metropolitan Municipality (EKU), Metsweding District Municipality (DC46) and Kungwini Local Municipality (GT462) by excluding certain farms from Metsweding and Kungwini and by including them into Ekurhuleni, as reflected on the maps;
- b) City of Tshwane Metropolitan Municipality (TSH) and Metsweding District Municipality (DC46) by including the remaining portion of Metsweding into City of Tshwane.

Any person aggrieved by the re-determinations may submit objections within 30 days of publication of this notice to:

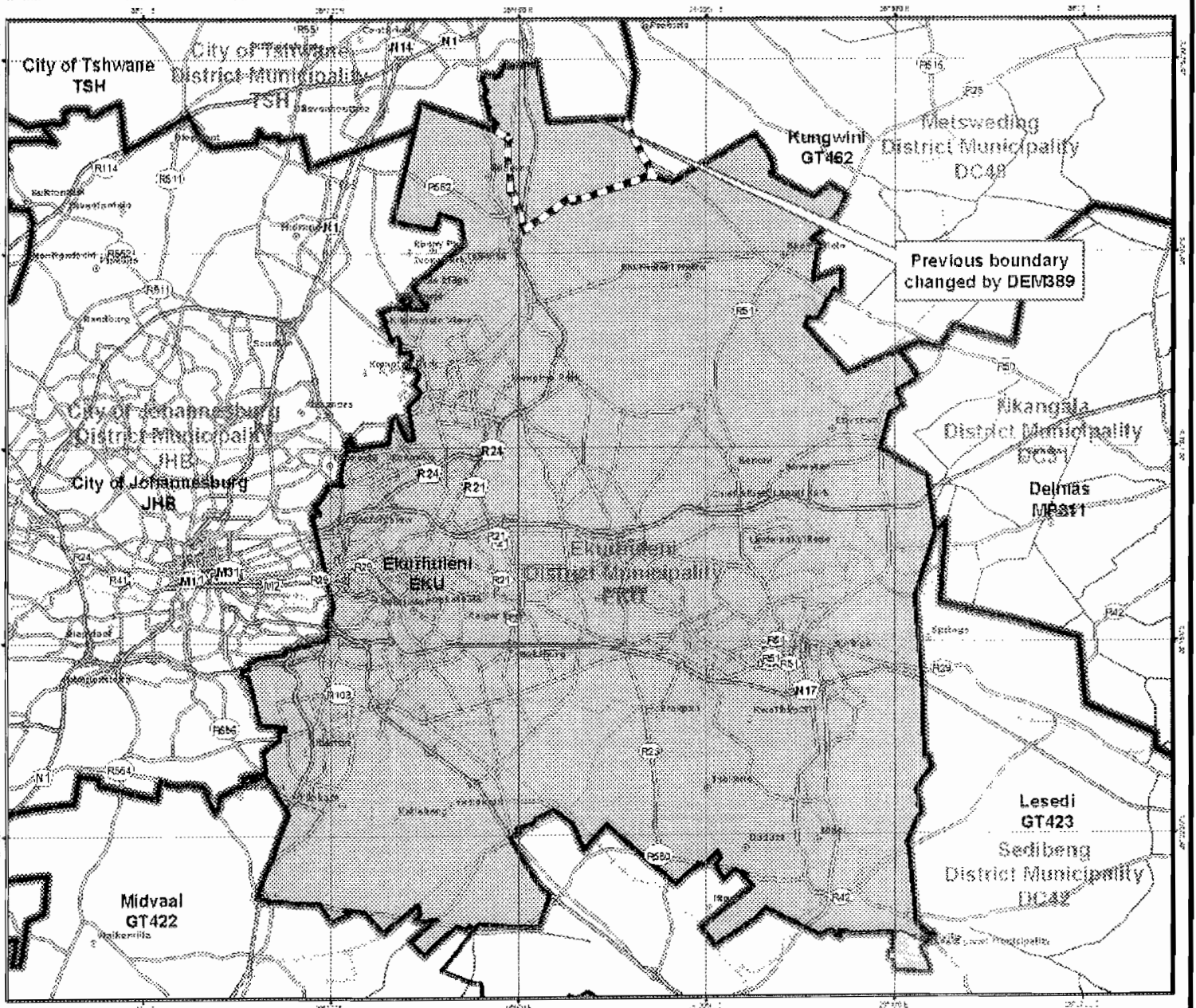
