LOCAL AUTHORITY NOTICE 806

DIRECTOR GENERAL NOTICE GAUTENG PROVINCIAL GOVERNMENT PROPOSED DAWN PARK EXTENSION 7 TOWNSHIP DECLARATION OF APPROVED TOWNSHIP

In terms of the provisions of Section 69 of the Town Planning and Townships Ordinance, 1965, the Gauteng Provincial Government hereby declares Dawn Park Extension 7, situated on Portion 98 (a Portion of Portion 18) of the Farm Rondebult 136 I.R. to be an approved township, subject to the conditions set out in the schedule hereto.

SCHEDULE

CONDITIONS UNDER WHICH THE APPLICATION MADE BY QUANTUM PROPERTY HOLDINGS (PTY) LTD IN TERMS OF THE PROVISIONS OF THE TOWN-PLANNING AND TOWNSHIPS ORDINANCE, 1965, (ORDINANCE 25 OF 1965) FOR PERMISSION TO ESTABLISH A TOWNSHIP ON PORTION 98 (A PORTION OF PORTION 18) OF THE FARM RONDEBULT 136 I.R., GAUTENG HAS BEEN APPROVED.

1. CONDITIONS OF ESTABLISHMENT

(1) NAME

The name of the township shall be Dawn Park Extension 7.

(2) DESIGN

The township shall consist of erven and streets as indicated on S.G. Plan No 10027/2007

(3) STORMWATER DRAINAGE AND STREET CONSTRUCTION

(a) The township owner shall on request by the local authority submit to such authority for its approval a detailed scheme complete with plans, sections and specifications, prepared by a civil engineer approved by the local authority, for the collection and disposal of storm water throughout the township by means of properly constructed

works and for the construction, tarmacadamising, kerbing and channelling of the streets therein together with the provision of such retaining walls as may be considered necessary by the local authority.

Furthermore, the scheme shall indicate the route and gradient by which each erf gains access to the street on which it abuts.

(b) The township owner shall, when required by the local authority to do so, carry out the approved scheme at its own expense on behalf and to the satisfaction of the local authority under the supervision of a civil engineer approved by the local authority.

(c) The township owner shall be responsible for the maintenance of the streets to the satisfaction of the local authority until the streets have been constructed as set out in sub clause (b).

- (d) If the township owner fails to comply with the provisions of paragraphs (a), (b) and (c) hereof the local authority shall be entitled to do the work at the cost of the township owner.

(4) DISPOSAL OF EXISTING CONDITIONS OF TITLE

All erven shall be made subject to the following existing conditions and servitudes, if any, including the reservation of rights to minerals but excluding a 2 meter wide water pipeline servitude in favour of the Ekurhuleni Metropolitan Municipality as set out in Notarial Deed of Servitude No. K001555 09 S with Diagram S.G. No.398/2008 relating thereto which affects Erven 3612 to 3618, 3746 to 3763, 3931 to 3933, 3936, 3942 and 3943 and Streets in the township only.

(5) ACCESS

No ingress or egress shall be permitted along all erven abutting Route K136, erven abutting Galahad Way in Dawn Park Extensions 3 and 8, erven abutting West Central Road in Dawn Park Extension 2, as well as the erven abutting Hassink Highway.

(6) DEMOLITION OF BUILDINGS AND STRUCTURES

The township owner shall at its own expense cause all existing buildings and structures situated within the building line reserves, side spaces or over common boundaries to be demolished to the satisfaction of the local authority, when required by the local authority to do so.

(7) OBLIGATIONS IN REGARD TO ESSENTIAL SERVICES

The township owner shall within such period as the local authority may determine, fulfil its obligations in respect of the provision of water, electricity and sanitary services and the installation of systems therefore, as previously agreed upon between the township owner and the local authority.

(8) REMOVAL OR REPLACEMENT OF MUNICIPAL SERVICES

If by reason of the establishment of the township, it should become necessary to remove or replace any existing municipal services, the cost thereof shall be borne by the township owner.

(9) LAND FOR PUBLIC PURPOSES

The following erven shall be transferred to the local authority by and at the expense of the township applicant:

Public Open Space : Erven 3942 and 3944 to 3950

2. CONDITIONS OF TITLE

The erven mentioned hereunder shall be subject to the conditions as indicated imposed by the Administrator in terms of the provisions of the Town-planning and Townships Ordinance, 1965.

(1) ALL ERVEN

- (a) The erf is subject to a servitude, 2 m wide, in favour of the local authority, for sewerage and other municipal purposes, along any two boundaries other than a street boundary and in the case of a panhandle erf, an additional servitude for municipal purposes 2 m wide across the access portion of the erf, if and when required by the local authority: Provided that the local authority may dispense with any such servitude.
- (b) No building or other structure shall be erected within the aforesaid servitude area and no large-rooted trees shall be planted within the area of such servitude or within 2 m thereof.
- (c) The local authority shall be entitled to deposit temporarily on the land adjoining the aforesaid servitude such material as may be excavated by it during the course of the construction, maintenance or removal of such sewerage mains and other works as it in its discretion may deem necessary and shall further be entitled to reasonable access to the said land for the aforesaid purpose subject to any damage done during the process of the construction, maintenance or removal of such sewerage mains and other works being made good by the local authority

BOKSBURG AMENDMENT SCHEME 1626**

The Ekurhuleni Metropolitan Municipality hereby in terms of the provisions of Section 125 (1) of the Town-planning and Townships Ordinance, 1986, declares that it has adopted an amendment scheme, being an amendment of the Boksburg Town Planning Scheme, 1991, relating to the land included in Dawn Park Extension 7 township.
