### **CORRECTION NOTICE**

General Notice No. 145 published in Provincial Gazette Extraordinary No. 4 of 09 January 2009 is rectified as follows:

- (1) In the third and fourth line of the paragraph delete the phrase "an authorization, permit or" where it appears respectively and replace it with the word "a";
- (2) in the third line of the paragraph delete the word "two" and replace it with the word "four".

**CORRECTION NOTICE IN RESPECT OF THE  
SECOND GAUTENG LIQUOR AMENDMENT REGULATIONS, 2008**

General Notice No. 146 published in Provincial Gazette Extraordinary No. 4 of 09 January 2009 is rectified as follows:

- (1) Clause 2 of the Schedule relating to the insertion of Regulation 2A
  - (a) Sub-regulation (1) should read as follows:

*"(1) The applicant must apply for the conversion of a license issued under the Liquor Act, 1989 (Act No. 27 of 1989) in accordance with section 143(2) of the Act, on a form similar to Form 11 set out in Schedule 2."*
  - (b) Sub-regulation (3) should read as follows:

*"(3) The applicant must submit the application form together with proof of payment of conversion fee, certified copy of the original license and certified copies of proof of renewal fees paid for 2007, 2008 and 2009 to the offices of the Department, situated at 94 Main Street, Johannesburg."*
  - (c) Sub-regulation (4) should read as follows:

*"(4) The Board must issue an acknowledgement of receipt on submission of an application as contemplated in sub-regulation (3)."*
  - (d) The following sub-regulation is inserted after sub-regulation (4):

*"(4A) A license issued in terms of the Liquor Act, 1989 (Act No. 27 of 1989) to engage in the retail sale or micro-manufacture of liquor or methylated spirits remains valid until the Board has converted the license as contemplated in sub-regulation (5)."*

(e) Sub-regulation (5) should read as follows:

*"(5) The Board must issue a license under the Act within 90 days of lodging of an application as contemplated in sub-regulation (3)."*

(f) Delete the phrase "authorization, permit or" where it appears in sub-regulation (6).

(g) The following sub-regulation is inserted after sub-regulation (6):

*"(7) A license issued in terms of sub-regulation (5) is subject to the conditions set out in section 98 of the Act."*

(2) In Clause 3 of the Schedule relating to the amendment of Schedule 1 delete the fee of "R200-00" in item 10 and replace it with the fee "R1200-00".

(3) In Cause 4 of the Schedule relating to the amendment of Schedule 2 substitute the following form for Form 11:
