PRELIMINARY DESIGN FOR PROVINCIAL ROAD K54

In terms of section 8(6) and (7) of the Gauteng Transport Infrastructure Act, 2001 (Act No 8 of 2001) ("the Act") it is hereby notified for general information that the Member of the Executive Council for the Gauteng Province ("the MEC") for Public Transport Roads and Works has considered and accepted the amended Preliminary Design of a portion of provincial road K54, between Nellmapius Road and the Albertina Sisulu Highway (P157-1) for implementation. The acceptance concerns those sections of the provincial road published for public comments on the 21 November 2008 in the Provincial Gazette.

It should further be noted that the regulatory measures provided for in section 7 of the Act in respect of the route cease to apply from the date of this notice to the extent of the route along or over which the preliminary design was accepted by the MEC in terms of the section 8(6) of the Act and that the regulatory measures contained in section 9 of the aforementioned Act apply with relation to the accepted preliminary design from the date of this notice.
