Attention is specifically drawn to the fact that in terms of section 50(2) of the Act an objection must be in relation to a specific individual property and not against the valuation roll as such. The form for the lodging of an objection is obtainable from the listed Municipal Offices, or website www.ekurhuleni.com. Alternatively, an e-mail with only the Account Number of the property in the subject line can be sent to objections@emm.evaluations.co.za and the relevant objection form for that property will be sent electronically to such requester.

The completed objection forms must be returned **by hand** to any of the listed Municipal Offices. Kindly bring along your Section 49 notice when submitting your objection, as this will expedite the submission process.

No form of electronic submission will be accepted. CLOSING DATE FOR OBJECTIONS IS 16:00 ON FRIDAY 17 APRIL 2009. No late objections will be accepted.
