HAVE YOUR SAY ON THE PROPOSED PRINCIPAL PUBLIC ROADS. EXCLUSION ZONES AND CONTROLLED ACCSESS SITES APPLICABLE TO THE 2010 FIFA WORLD CUP SOUTH AFRICA BY LAWS.

... The City of Johannesburg gives notice of its intention to adopt Schedules identifying the Principal Public Roads, Exclusion Zones and Controlled Access Sites envisaged in the 2010 FIFA World Cup South Africa by laws promulgated in the Provincial Gazette Extraordinary No:36 16 February 2009. These Schedules will regulate aspects of the conduct of business within identified areas during the term for which the by-laws will be applicable, namely for a period two weeks prior to the first match of the Soccer World Cup competition until two weeks immediately following the final match.

The City invites individuals, organisations, companies, institutions and any interested party to submit written comments to these proposed Schedules. The closing date for submission of written comments is 19 March 2010 (this date could be moved closer to the date of the public hearing to allow a reasonable time for receipt of the submissions).

A Public Hearing for oral submissions will be held on the 27 March 2010, from 9:00 to 13:00 at the City of Johannesburg, Metropolitan Centre, Council Chamber Wing, 158 Loveday Street, Braamfontein.

2010 FIFA WORLD CUP SOUTH AFRICA PRINCIPAL PUBLIC ROADS, EXCLUSION ZONES AND CONTROL ACCESS SITES

The City of Johannesburg hereby gives notice in terms of the 2010 FIFA World Cup South Africa By-laws published under Local Authority Notice 224 in *Provincial Gazette Extraordinary* No. 36 of 16 February 2009 that it intends to declare Exclusion Zones in the immediate vicinity of Ellispark and Soccer City stadiums, the City further intends to designate Innes Free Park and Elka Stadium as Controlled Access Sites by virtue of their status as FIFA Fan Parks and to designate a number of roads as Principal Public Roads for the purposes of the 2010 FIFA Soccer World Cup.

The purpose of the designation of the Exclusion Zones is to regulate business activities within the Exclusion Zones on match days. No person shall be permitted to conduct business activities on a match day within an Exclusion Zone without the written approval of the City of Johannesburg acting in consultation with FIFA and the Local Organising Committee.

The purpose of the designation of the specified roads as Principal Public Roads is to regulate advertising activities along these roads during the term for which the City's 2010 FIFA World Cup By-laws will be applicable, namely for a period of two weeks prior to the first match of the competition until two weeks immediately following the final match. Similarly, advertising activities will be regulated in the vicinity of the FIFA Fan Parks. No person shall be permitted to conduct advertising activities on a Principal Public Road or within a 100 meter radius of a FIFA Fan Park, without the written approval of the City of Johannesburg acting in consultation with FIFA and the Local Organising Committee.

Details of the proposed Principal Public Roads, FIFA Fan Parks and Exclusion Zones are annexed hereto and can be obtained from the 2010 project office at 125 Simmonds Street, corner of Simmonds and Stiemens Streets, Braamfontein, or at the Metrolink Building, Metropolitan Centre, 158 Loveday Street, Braamfontein, on weekdays from 08h30 to 16h00.

Any person who wishes to comment upon this proposal or to apply for permission to conduct advertising activities along these roads or business activities within the Exclusion Zones or within Control Access Sites should do so in writing before 19 March 2010. Such representation should be sent by e-mail to Lutendos@joburg.org.za or by fax to (011) 381-0399 and marked for the attention of Mr Lutendo Siphugu.

A public hearing where verbal representations may be made will be held on Saturday, 27 March 2010 at 09h30 at Ground Floor, Metropolitan Centre, 158 Loveday Street, Braamfontein.
