EXTENSION OF DECLARATION OF LOCAL STATE OF DISASTER**

**NOTICE IS HEREBY GIVEN** in terms of section 55 (5) of the Disaster Management Act, Act No 57 of 2002, that the Executive Mayor of the Ekurhuleni Metropolitan Municipality in terms of his delegated powers, further extended the declaration of the Bapsfontein Informal Settlement area as a local state of disaster due to the dolomite instability of the area as declared in Notice number 1643 of the Provincial Gazette number 220 dated 10 December 2010, extended by Notice number 260 dated 9 March 2011 to 10 April 2011, extended by Notice number 396 dated 8 April 2011 to 10 May 2011, extended by Notice number 565 dated 6 May 2011 to 10 June 2011, extended by Notice number 714 dated 9 June 2011 to 10 July 2011, with a further month until 10 August 2011. The Bapsfontein Informal Settlement of 25 hectares is bordered by the R25 Provincial Road to the East and is located approximately 300 metres to the North of the R25 Provincial Road within the Ekurhuleni Metropolitan Municipal Area.
