 - 2.3 ERVEN 1932, 1933, 1936, 1937, 1940, 1941, 1944, 1945, 1946 and 1948 are subject to a servitude 1,00 metres wide as shown on the General Plan
 - 2.4 ERVEN 1929 and 1969 are subject to a servitude as shown on the General Plan
 - 2.5 Erf 1952 is subject to a servitude 3,00 metres wide as shown on the General Plan
