INVITATION FOR THE NOMINATION OF MEMBERS OF THE GAUTENG CONSUMER AFFAIRS COURT

In terms of section 14 of the Consumer Affairs (Unfair Business Practices Act, 1996 (Act No 7 of 1996) the member of the Executive Council responsible for Economic Development hereby calls for nominations for members to serve in the Consumer Affairs Court.

1. All interested persons are hereby invited to submit their written nominations for appointment of members to the Consumer Affairs Court.
2. Members of the court shall appointed by the responsible Member of the Executive Council in Concurrence with the standing Committee of Economic Affairs.

The court shall consist of five persons, namely-

(a) a chairperson, who shall be-

(i) retired judge of the Supreme Court; or

(ii) an attorney, advocate, retired magistrate or lecturer in law at a university, with no less than ten years cumulative experience in one or more such capacities;

(b) four additional members having special knowledge or experience of consumer advocacy, economics, industry or commerce.

3. No persons shall be appointed or remain a member of the court if he or she is not a fit and proper person or-

(a) is not a citizen of Republic resident in the Province;

(b) is a public servant;

(c) at the relevant time is, or during the preceding twelve months was, an office-bearer employee of any party, movement, organization or body of a party political nature;

(d) is an unrehabilitated insolvent;

(e) has at any time been convicted, whether in the Republic or elsewhere, of theft, fraud, forgery or uttering a forged document, perjury, an offence under this Act or the Corruption Act, 1992 (Act No. 94 of 1992), or any offence involving dishonesty;

(f) has at any time been removed from an office of trust on account of misconduct.

The nominees must include the following information:

- ❖ full name of nominee.
- ❖ a certified copy of the nominee's identity document.
- ❖ a certified copy of the nominee's qualifications.
- ❖ detailed Curriculum Vitae of the nominee.
- ❖ motivation for the nomination.
- ❖ a letter from the nominee accepting to serve as a member of the Court.

A person may nominate himself or herself. The nominations shall be submitted within 21 days after date of publication to:

VERSOEK VIR DIE BENOEMING VAN LEDE VIR DIE GAUTENGSE VERBRUIKERSHOF

Die Lid van die Uitvoerende Raad verantwoordelik vir finansie ek ekonomiese sake versoek hiermee ingevolge artikel 14 van die verbruikersake (Onbilige Sakepraktyke Wet 1996 (Wet No 7 van 1996) alle benoemings van lede om in die Verbruikershof te dien.

- (i) Alle belanghebbendes word hiermee versoek om geskrewe benoemings vir aanstellings as lede aan die Verbruikershof in te dien.
- (ii) Lede van die hof sal deur die verantwoordelike Lid van die Uitvoerende Raad in samewerking met die Staande Komitee vir Ekonomiese Ontwikkeling aangestel word.
- (iii) 'n Hof bestaan uit vyf persone, naamlik 'n voorsitter, wat 'n afrede regter van die Hoog-geregshof, 'n prokureur, advokaat, afgetrede landros of dosent in regte aan 'n uni versiteit is, moet nie minder nie as 10 jaar opgeloopte ervaring in een of meer sodanige hoedanigheid assok
- (iv) Vier bykomende lede met spesiale kennis van of ervaring in verbruikersvoorspraak, die ekonomie, handel of nywerheid.
- (v) Die verantwoordelike Lid kan 'n alternatiewe lid vir elke lid van die hof aanstel.
- (vi) Niemand sal angstel word of lid van die hof bly nie indien hy of sy:
 - nie 'n geskikte en gepaste persoon is nie; of
 - nie 'n burger van die Republiek is nie en in die provinsie woonagtig is nie;
 - 'n staatsampenaar is;
 - op die betrokke tydspit of in in voorafgaande 12 maande 'n ampsdraer of werknemer van enige party;
 - beweging, organisie of liggaam van 'n partypolitieke aard was;
 - 'n ongerehabiliteerde insolvent is;
 - te eniger tyd skuldig bevind is aan diefstal, bedrog, vervalsing, uitgifte van 'n vervalste dokument, meened, 'n misdryf ingevolge, hierdie Wet of die Wet op korrupsie, 1992 (Wet No 94 van 1992) of enige misdryf waarby oneerlikheid betrokke is; of
 - te eniger tyd weens wangedrag uit 'n verantwoordelike amp ontstaan is.
- (vii) Die benoeming moet die volgende inligting bevat:
 - Volle name van die benoemde
 - 'n Gesertifiseerde afskrik van benoemde se identiteitsdokument
 - 'n Gesertifiseerde afskrik van benoemde se kwalifikasies
 - Uitvoerige curriculum vitae van die benoemde
 - Motivering vir die benoeming
 - 'n brief waarin die benoemde instem om as lid van die hof te dien

Enigeiemand kan hom of haarself benoem. Die sluitingsdatumvir benoemings is 21 (een en twintig) dae datum van publikasie van hierdie kennisgewing.
