CALL FOR MEMBERS OF THE AUDIT AND RISK COMMITTEE FOR THE GAUTENG GAMBLING BOARD

In terms of Section 77 of the Public Finance Management Act (PFMA), the Gauteng Gambling Board calls on all qualified and interested persons to serve as members of the Audit and Risk Committee for the Gauteng Gambling Board.

Requirements:

- A post graduate degree or equivalent qualification in Finance, Accounting, Auditing or Risk Management;
- Extensive experience in finance, accounting, auditing, risk management, sustainability issues and information technology governance as it relates to integrated reporting;
- 10 years or more Senior Management experience;
- Thorough understanding of entities and regulatory issues;
- Familiarity with the Public Finance Management Act (PFMA), Treasury Regulations and King III;
- Proven leadership skills;
- Excellent analytical skills;
- Good communication skills;
- Have the best interest of the Board at heart, and must display the highest levels of integrity;
- Sufficient time available to prepare and attend Committee meetings;
- Independence and objectivity;

Familiarity with gambling legislation would be an advantage.

Candidates may apply personally or be nominated by others. All applications must be accompanied by certified copies of all relevant qualifications.

Nominated candidates need to indicate their acceptance of the nomination to serve on the Audit and Risk Committee. Only citizens of the Republic who reside in the Province of Gauteng will be considered.

Responsibilities

The responsibilities of the Audit and Risk Committee members are clearly outlined in terms of Section 77 of the PFMA, Treasury Regulations 3.1 and King III.

Term of office

The term of office of appointed candidates will be three (03) years, after which it may be reviewed by the Board.

Remuneration

The remuneration of the members of the Audit and Risk Committee is determined by the MEC responsible for gambling in Gauteng and is in line with the SAICA/AG tariffs per annum. There are a minimum of four meetings held per financial year.
