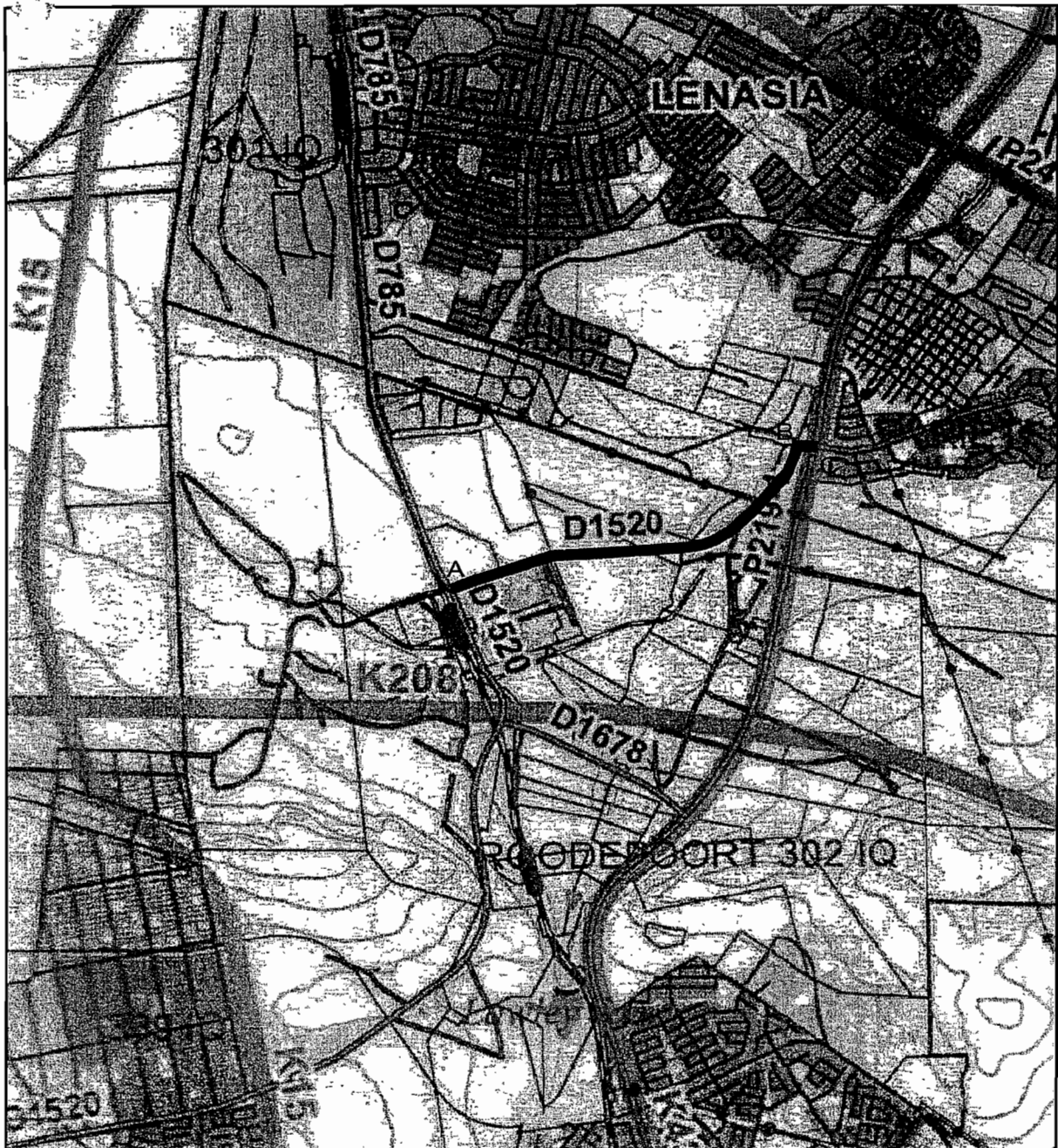
NOTICE 1160 OF 2010

It is hereby notified for general information that the portion of the aforementioned road is no longer a provincial road for the purposes of the said Act as from the date of this Notice.
