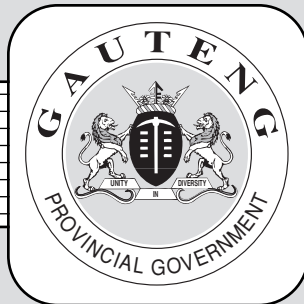

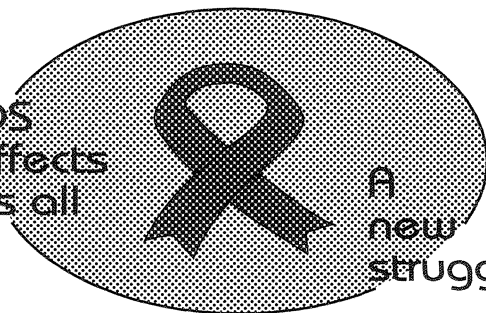

#### NOTICE IN TERMS OF SECTION 33 OF THE LOCAL GOVERNMENT: MUNICIPAL FINANCE MANAGEMENT ACT, NO 56 OF 2003: VALKFORTEIN EXTENSION 13 AND 20

**NOTICE IS HEREBY GIVEN** in terms of Section 33 of the Local Government: Municipal Finance Management Act, No. 56 of 2003 that the Ekurhuleni Metropolitan Municipality ("the Municipality") intends entering into an agreement which will impose financial obligations on the Municipality for a period longer than three years covered in the annual budget for the financial year 2014/2022. The contract relates to provision of Bulk Essential Services by the Township Owner of Valkfontein Extension 13 and 20 in excess of its obligation, and the repayment thereof by the Municipality by way of a rebate of future rates and taxes over a period of approximately 5 years, from the date when the occupancy certificate is issued.

**NOTICE IS FURTHER GIVEN** in accordance with Section 21 and Section 21A of the Local Government: Municipal Systems Act, No 32 of 2000 that –
