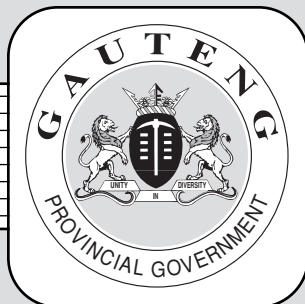

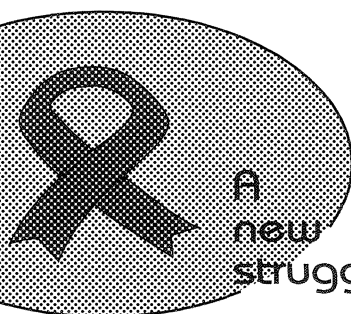

**Gauteng Gambling and Betting Act 1995  
Application for a Gaming Machine License**

Notice is hereby given that:

- Christine Da Silva trading as **The Malt and Barley** of Shop 1 Darras Shopping Centre. Corner of Juno and Kitchener Roads, Kensington;
- Blikkies Dorp Restaurant CC trading as **Blikkies Dorp Restaurant** of 55 Lanham Street, Bronkhorstspuit, Pretoria;
- Mags Management CC trading as **Egoli Night Club and Restaurant** of Shop 2004 Windsor Gardens, 23 Bok Street Corner of 43 King George Street, Joubert Park, Johannesburg;

Intends submitting an application to the Gambling Board for a Gaming Machine Licenses at the abovementioned sites. These applications will be open for public inspection at the offices of the Board from **13 August 2012**.

Attention is directed to the provisions of Section 20 (1) (a) of the Gauteng Gambling Act, 1995 which makes provision for the lodging of written representations in respect of the application.

Such representations should be lodged with the Chief Executive Officer, Gauteng Gambling Board, Private Bag 15, Bramley, 2018, within one month from **13 August 2012**.

Any person submitting representations should state in such representation whether or not they wish to make oral representations at the hearing of the application.
