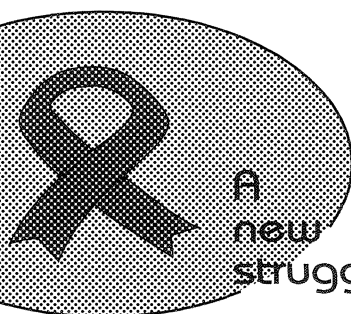

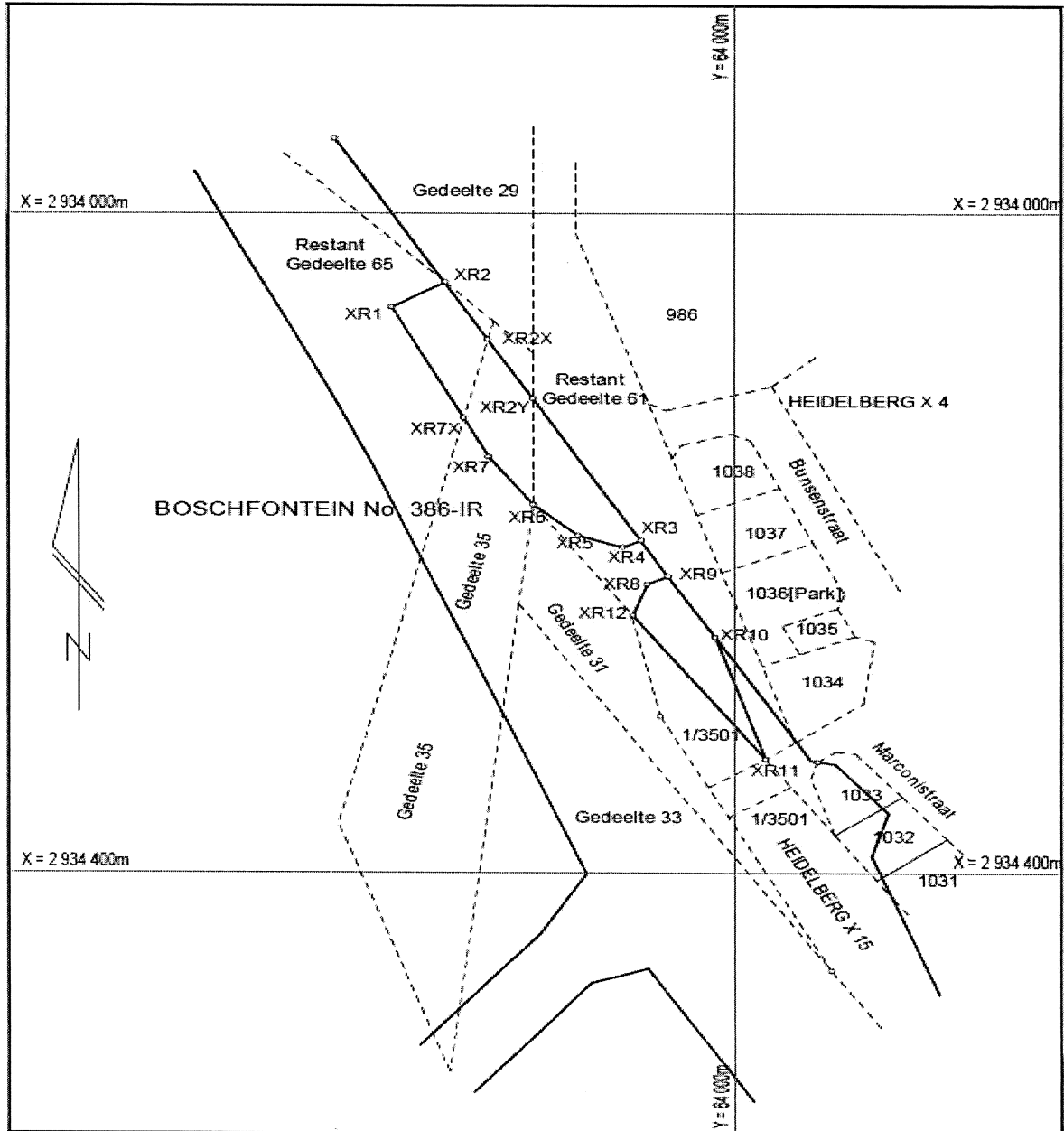
NOTICE 1941 OF 2012
