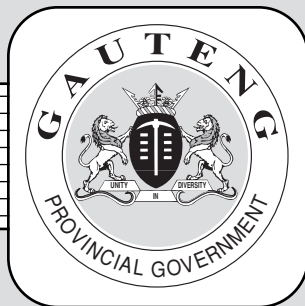

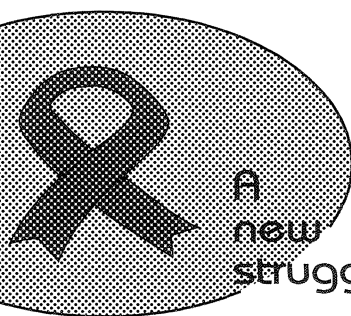

### GENERAL NOTICE 2254 OF 2012

#### GAUTENG DEVELOPMENT TRIBUNAL: CASE GDT/LDA/CJMM//1302/04/010 CORRECTION NOTICE

In terms of the provisions of the Development Facilitation Act, 1995, (Act 67 of 1995) General Notice 1332/2012 (published as an extraordinary notice in the Gauteng Provincial Gazette on 7 June 2012) is hereby amended and corrected in the following manner:

Substitute the following expression in the preamble of the notice: "...comprising 49 erven, numbered 650 to 698, 1 park numbered 699 and streets..." of the English and Afrikaans text with the expression "...comprising 50 erven, numbered 650 to 699 (inclusive of one park erf numbered 699) and streets ...".

#### GAUTENG ONTWIKKELINGS TRIBUNAAL: SAAK GDT/LDA/CJMM/1302/04/010 KORREKSIE KENNISGEWING

Ingevolge die bepalings van die Wet op Ontwikkelings Fasilitering, 1995, (Wet 67 van 1995) word Algemene Kennisgewing 1536/2012 (gepubliseer as 'n buitengewone kennisgewing in die Gauteng Provinsiale Koerant op 7 Junie 2012), hiermee op die volgende wyse verander en gekorrigeer:

Vervang die volgende uitdrukking in die aanhef van die kennisgewing: "...bestaande uit 49 erwe, genommer 650 tot 698, 1 park genommer 699 en strate..." in die Engelse en Afrikaanse bewoording met die uitdrukking "...bestaande uit 50 erwe, genommer 650 tot 699 (insluitende 1 park erf genommer 699) en strate...".
