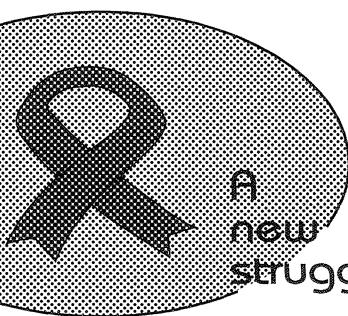

Notice is hereby given that Betting World (Pty) Ltd at 166 Jan Smuts Ave, Thebe House, intends submitting an application to the Gauteng Gambling Board to take transfer of a bookmaker's licence from Ken Ti Wong Chie and Bettina Fiona Kwan at 16 Jorrisen Street, Braamfontein, Johannesburg, and to relocate from 16 Jorrisen Street, Braamfontein, Johannesburg to 195 Bree Street, Johannesburg. The application will be open to public inspection at the offices of the Board from 01 October 2012.

Attention is directed to the provisions of Section 20 of the Gauteng Gambling Act, 1995 which makes provision for the lodging of written representations in respect of the application.
