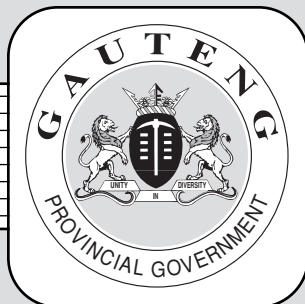

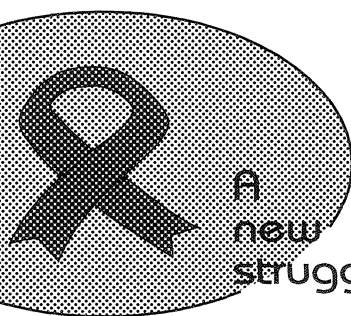

**NOTICE 1325 OF 2012**  
**MOGALE CITY LOCAL MUNICIPALITY**  
**NOTICE NO 30 OF 2012**  
**AMENDMENT SCHEME 1133**

It is hereby notified in terms of Section 57(1) of the Town-Planning and Townships Ordinance, 1986, that the Mogale City Local Municipality approved the amendment of the Krugersdorp Town Planning Scheme, 1980, by the rezoning of the Remainder of Erf 164 Krugersdorp North, from "Residential 1" with a density of one dwelling per erf to "Residential 3" subject to a certain conditions.

Copies of the application as approved are filed with the offices of the Municipal Manager: Development & Planning, First Floor, Furn City Building, Cnr of Human Street and Monument Street, Krugersdorp, and are open for inspection at all reasonable times.

This amendment is known as Krugersdorp Amendment Scheme 1133 and shall come into operation from the date of publication hereof.
