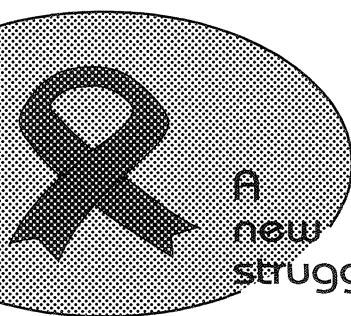

Notice is hereby given in terms of section 44(4) of the Rationalisation of Local Government Affairs Act, 1998, that the Ekurhuleni Metropolitan Municipality (Benoni Customer Care Area) has approved the extension for the restriction of access to public open places for safety and security purposes, being Erf 588 (park), a Portion of Libra, Carina, Aquarius, Nova, Apollo, Venus, Gemini, Antares Avenue, Vega Place Street and a Portion of Landau Street, Morehill Extension 2 Township, Benoni, for a period of 2 (two) years, subject to certain conditions.
