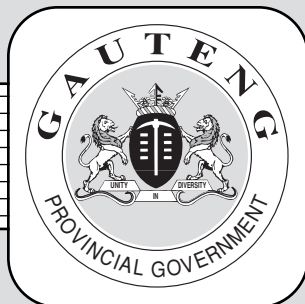

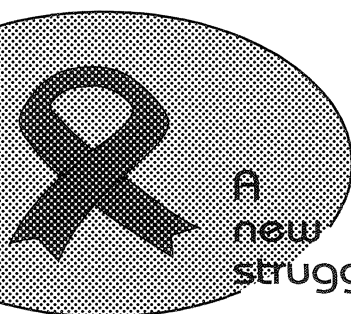

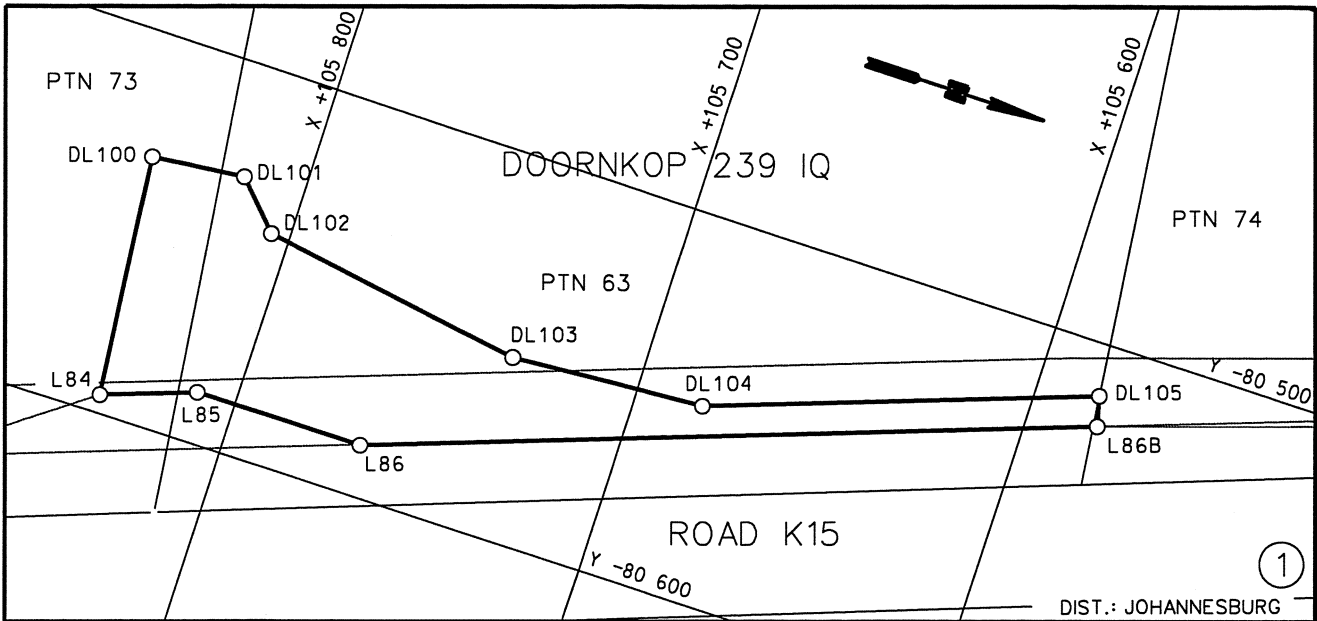
NOTICE 2765 OF 2012
