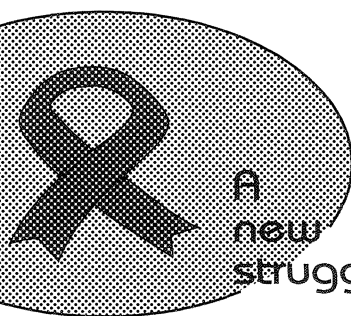

### NOTICE 2981 OF 2012

#### PROPOSED PROCLAMATION OF PROVINCIAL ROAD K133 (P4-1) BETWEEN NEDERVEEN / LEONDALE FORDSDICK ROAD TO BARRY MARAIS ROAD.

1. In terms of **regulation 13 of the Gauteng Transport Infrastructure Regulations, 2003** read with section 15 of the Gauteng Transport Infrastructure Act, 2001 (Act 8 of 2001) you are hereby notified that the Member of the Executive Council of the Province of Gauteng responsible for provincial roads (hereinafter referred to as the MEC) intends to **proclaim the widening of K133 (P4-1) and access roads in connection with K133 between Nederveen / Leondale Fordsdick Road to Barry Marais Road** over inter alia the under mentioned land in terms of sections 11 (2) and 13 respectively of the Gauteng Transport Infrastructure Act, 2001 (Act 8 of 2001).
  
2. As the whereabouts / addresses of the owner(s) are unknown, a notice in terms of section 35(1) is hereby published requesting affected and interested parties as well as land owners to liaise with the Department within 14 days of the publication of this notice regarding the proposed proclamation of the said road.
