

- 1. DETERMINATION OF A BUS RAPID TRANSIT ROUTE: PRETORIA CBD: PAUL KRUGER STREET FROM NANA SITA STREET TO WONDERBOOM STATION: BRT LINE 1; AND
- 2. FIXING OF BUS RAPID TRANSIT STATIONS: PAUL KRUGER STREET BETWEEN FRANCIS BAARD STREET AND WONDERBOOM STATION

Notice is hereby given, in terms of section 65bis (2) of the Local Governance Ordinance 17 of 1939, that the City of Tshwane Metropolitan Municipality intends to:-

- determine a bus rapid transit route between Pretoria CBD and Wonderboom Station and back. The Route description is as follows:
- The route starts at the intersection of Paul Kruger Street and Nana Sita Street (Skinner Street). It then proceeds north along Paul Kruger Street, turning right into Mansfield Road, proceeding north along Mansfield Road, until the junction with Paul Kruger Street. Here the route rejoins Paul Kruger Street (R101) and terminates at Wonderboom Station and return back to the CBD; and
- fix 7 (seven) bus rapid transit stations on the median island between Pretoria CBD and Wonderboom Station as follows:
