

#### NOTICE FOR THE TRANSFER OR RELOCATION OF SHEBEEN PERMITS.

I, Nkosiphendule Kolisile, member of the Executive Council responsible for Economic Development hereby invite holders of valid shebeen permits wishing to transfer, and those who have relocated the premises to apply for the transfer or relocation of such shebeen permit.

The person wishing to transfer a permit must be an immediate family member of the shebeen permit holder and such application must be accompanied by:

- Original shebeen permit or certified copy of the permit.
- Certified copy of the ID of the person applying for the transfer.
- Affidavit commissioned at South African Police confirming the address of the premises and that the person has been trading in liquor and the duration thereof.
- Statement of account not older than three (3) months, reflecting your name and physical address.
- Colour photographs depicting the internal and external features of the premises

If original shebeen owner died, please submit the following:-

- · Copy of a death certificate
- Letters of Authority from the Masters of the High Court or a letter from Local Magistrate indicating who is appointed Executor of the Estate or the final Liquidation and Distribution Account.

- Affidavit from the South African Police confirming the relationship of the applicant to the deceased.
- Copy of the Title Deed, certificate of Title or any other form to show ownership. If not owner, copy of the lease agreement or if operating in rural area, copy of PTO (Permission to Occupy).

#### The application for the relocation of the permit must be accompanied by:

 Affidavit confirming the linkage of the holder of shebeen permits to the address that is in the permit.
