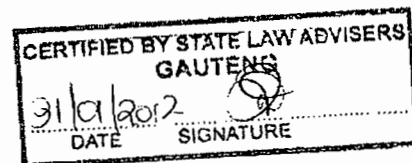



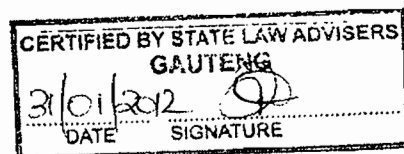

Short title and commencement
